- Develop communication framework for Fellowship Program;
- Conduct and/or shadow due diligence of prospective companies and funds;
- Industry research;
- Attend any relevant meetings or events, if in person.

SCHEDULE OVERVIEW

Initially, we will hold larger group sessions for Partners to teach various aspects of the venture business. We will mix in individual assignments and research with larger group sessions and ensure that all candidates have exposure to the various elements of a venture firm. *Note that the schedule is largely dependent on timing, duration, and location (virtual or in-person) of the program).*

DESIRED SKILLS/QUALIFICATIONS

Desire to learn and passion for our mission is paramount. Candidates should be proactive thinkers and self-starters, able to move quickly yet impactfully between the various aspects of the firm given short time commitment. Given the potential of a remove experience, strong communication skills and the ability to remain engaged during both group sessions and independent tasks are imperative. Some experience in personal investing or interest in technology and/or venture capital is helpful but not at required.
