
Key Reminders

- When completing Player Corporation information, you will NEED to submit the individual direct deposit form using a separate link.
- Individual banking information MUST be different than the Player Corporation banking information
- When PLAYERS are accessing the DocuSign link to review and sign the documents, the access code may be sent to a spam or junk folder










